Integrated Health Home Health Home Notification Form Guide

Introduction

This is to assist in providing the Health Home with information on criteria and how to enroll the member into an Integrated Health Home (IHH).

Enrollment criteria

Member needs to:

- Be eligible for Medicaid.
- Have one or more serious mental illness (SMI) or serious emotional disturbance (SED).
- Meet the functional impairment (FI) as determined by a licensed mental health professional.

SMI & SED definitions

Diagnosis must be determined by use the diagnostic and statistical manual (DSM) of mental disorders published by the American Psychiatric Association or its most recent International Classification of Diseases (ICD).

SMI is defined as an adult who has a persistent or chronic mental illness, a behavioral, or emotional disorder that causes serious functional impairment and substantially interferes with or limits one or more major life activities including functioning in the family, school, employment, or community. SMI may co-occur with substance use disorder, developmental, neurodevelopmental, or intellectual disabilities, but those diagnoses may not be the clinical focus for health home services.

SED is defined by a child having a diagnosable mental, behavioral, or emotional disorder, which results in a functional impairment that substantially interferes with or limits the child's role or functioning in family, school, or community activities. SED may co-occur with substance use disorder, developmental, neurodevelopmental, or intellectual disabilities but those diagnoses may not be the clinical focus for health home services.

Mental health professional definition

Mental health professional meets all of the following conditions:

 Holds at least a master's degree in a mental health field including, but not limited to, psychology, counseling and guidance, psychiatric nursing, and social work; or is a doctor of medicine or osteopathic medicine; and Integrated Health Home Health Home Notification Form Guide Page 2 of 15

- Holds a current Iowa license when required by the Iowa professional licensure laws (such as a psychiatrist, a psychologist, a marital and family therapist, a mental health counselor, an advanced registered nurse practitioner, a psychiatric nurse, or a social worker); and
- Has at least two years of post-degree experience supervised by a mental health professional in assessing mental health problems, mental illness, service needs and in providing mental health services.

Functional impairment definition

The level of functional impairment must be identified by an assessment completed by the licensed mental health professional. It must be signed and dated within 365 days of enrollment.

Functional impairment (FI) means:

- The loss of functional capacity that is episodic, recurrent or continuous and
- Substantially interferes with or limits the achievement of or maintenance of one or more developmentally appropriate social, behavioral, cognitive, communicative or adaptive skills and
- Substantially interferes with or limits the individual's functional capacity with family, employment, school, or community.

When is functional impairment documentation required vs. not required to be sent in with notification form?

Scenario	Functional impairment to be sent in with notification form	Expectation
Enrollment as Non ICM (Tier 5/6)	Required	
Enrollment as ICM (Tier 7/8)	Not required	IHH should obtain documentation within 60 days and place in members record
MCO to MCO Non ICM (Tier 5/6)	Required

MCO to MCO ICM (Tier 7/8)	Not required	IHH needs to submit the PCSP and current assessment to the new MCO, for funding to be secured per their processes.
IHH to IHH Transfer	Not required	IHH needs to obtain within 60 days and place in members record
IHH to IHH Transfer (with new MCO)	Required	

Process

The following is a basic outline of how to submit enrollment to the MCOs:

- 1. The IHH meets with the member.
- 2. The IHH gathers the necessary documentation to verify member's diagnosis and functional impairment from qualified mental health professional.
- 3. The IHH completes the following sections on the *Health Home Notification Form*:

Section one: member information:

- Member name
- DOB
- Phone If member does not have one, put NA
- MCO assigned member ID number Required for Wellpoint members
- Medicaid ID number
- Home address If member is homeless, put NA

Section two: provider information:

- Health home name
- National Provider Identifier (NPI)
- MCO assigned provider # Required for Wellpoint members
- Primary care provider If member does not have one identified, put NA.

Section three: status:

- Check the appropriate box(es) for what is needed for the member:
 - Enrollment

- Change in Tier IHH:
 - Use when changing member from ICM (Tier 7/8) to Non ICM (Tier 5/6)
 - Must select the reason for the change in tier:
 - Member choice
 - Unable to contact
 - Other note reason in other box
- Disenrollment:
 - Must select the reason for the disenrollment:
 - Member choice:
 - When tier 7/8, in the other box indicate if the member is disenrolling from both IHH and Hab/CMHW or just the IHH.
 - Member not participating or provider unable to reach
 - Member transferred to another health home note in other box who they are transferring to
 - Member moved from area note in other box member's new address
 - Member no longer meets criteria
 - Member is effectively self-coordinating services
 - Member is deceased note in other box date of death
 - Member lost Medicaid Eligibility
 - Provider requested state in other box why
 - Provider terminated member enrollment—note in other box why
 - Member moved out of state note in other box member's new address and date moved
- Other:
 - May be checked in addition to another box listed above due to additional information needing to be provided, per stated above.
- Effective date of change:
 - Enrollment date This should always be the first of the month
 - Change in tier for the member This should always be the first of the month
 - Disenrollment date for the member This should always be the last day of the month
- Notes for status section:
 - Effective dates are determined by the IHH.
 - When a member is transferring from MCO to MCO, enrollment date can be back dated up to 90 days, as long as the member was eligible with that MCO.

- All other enrollments, changes in tier, disenrollments, etc. can be back-dated to the previous month.
- Transfers from IHH to IHH, member can only be enrolled in one health home per month.
 Health homes need to communicate with each other on effective dates. The disenrollment does need to be received prior to the enrollment being processed.

Section four: enrollment:

- Qualifying diagnosis codes:
 - Enter in ICD or DSM diagnosis codes
- Tier to enroll member:
 - Select appropriate one
- Notes for tier section:
 - If member is showing approved for Habilitation or CMH waiver per IMPA, member will be enrolled at that tier as long as the IHH indicates Habilitation or CMH waiver on the notification form.
 - If member is accessing Habilitation and is under the age 18, they will be enrolled at tier 8.
 - When member turns 18 and still accessing habilitation, the member's tier will automatically be changed to tier 7 by the MCOs (see Informational Letter 1690). The effective date will depend on when the member's birthday falls. For example:
 - If member turns 18 on the first of the month, the tier will change on the first of that same month.
 - If member turns 18 after the first of the month, the tier will change on the first of the following month.
 - IHH will need to submit a disenrollment if they no longer plan to serve member after they turn
 18. Pediatric IHHs should make a referral to an adult IHH prior to the member's 18th birthday if member is going to continue to receive IHH services or habilitation services.
 - If the IHH will continue to serve member after they turn 18, the IHH should complete appropriate paperwork (e.g. new ROIs) and submit a tier change form indicating pediatric to adult.
- Signature of HH staff, contact phone number and date:
 - Electronic signatures are approved
- 1. IHH will submit the *Health Home Notification Form* to the respective MCO along with supporting functional impairment information as indicated under *Functional Impairment Definition* above.
