

Medicaid eligibility check for Foundational Community Supports

Reference the following instructions to check Medicaid eligibility for the Foundational Community Supports (FCS) program.

How to check Medicaid eligibility for FCS

Log in to ProviderOne at waproviderone.org. Select Benefit Inquiry on the left panel. Search for the individual using their ProviderOne ID or full name and date of birth. Under the *Demographic and Response Information* section, the eligibility should display Active Coverage.



Under the *Client Eligibility Spans* section, Benefit Service Package must fall under one of the four statuses to be eligible for FCS:

- Alternative Benefit Plan (ABP): Client receiving Medicaid under the provisions of the Affordable Care Act, effective January 1, 2014
- Categorically Needy Program (CNP): Categorically needy, blind, and disabled
- CNP/Qualified Medicare Beneficiary (QMB): Client dually eligible for Medicare and Medicaid
- ABP/QMB: Client dually eligible for Medicare and Medicaid
